

Dream Car Calculations

Principal (loan amount) = Sale Price - Down Payment

Total Interest = Principal * Annual Interest Rate * Loan Term (in years)

Total Amount Paid = Principal + Total Interest

Number of Monthly Payments = Loan Term * 12

Monthly Payment = Total Amount Paid / Number of Monthly Payments

Use the formulas in Excel to calculate these values
